Sir,

This Directorate has received telephonic inquiries and letters from field offices regarding Election Model Code of Conduct and his applicability on PMEGP Scheme.

The matter was referred to the Election Commission of India, New Delhi for clarification on following points:-

1. There are few districts in which DTFCs were conducted during February, 2014. The District Collectors have taken some time to sign the DTFC minutes. Now, we are in receipt of the minutes. Whether the applications already selected by the DTFCs can be forwarded to the banks after the Model code of conduct has come in to force?

2. The DIC has also wanted to know whether banks can accord sanctions of the applications which were already forwarded to them before enforcement of Model code of conduct.

3. Whether the banks can release loan where the sanctions have already been accorded?

4. Whether margin money can be released to the cases where the banks have already disbursed loan?

It may also be clarified whether training of selected applicants under Entrepreneur Development Programme (EDP) can be conducted?

The Principal Secretary of Election Commission of India informed that the Commission has no objection on the proposal mentioned at Sr.No.2, 3 & 5. However applications selected after 5th March, 2014 shall be kept pending in the election is over. (Copy enclosed)

In view of above, it is requested to all State/Divisional Directors to comply the above order of the Election Commission of India and complete the PMEGP target 0f 2013-14.

It is once again requested that as per above directives of the Election Commission of India necessary actions may be taken by informing the above status to the KVIBs/DICs and Bankers to achieve the PMEGP performance for the year 2013-14.
