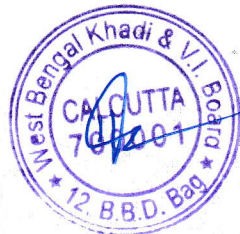

In the past, artisans were going to Sreerampore, Hooghly to develop their color on the above mentioned fabric. For this, the fabric cost increases and the valuable time of the artisans are in vein. In this context, WBKVIB intends to implement of the development programme for the color development of various fabric like Khadi, Muslin, Tassar and Silk (Natural Fibre) for the purpose of the generation of additional rural employment , development of skill, increasing productivity and upliftment of the earning of the Khadi, Muslin, Tassar and Silk artisans for having meaningful contribution towards improvement of the livelihood of said artisans.

For the above purpose “ Expression of Interest” is hereby invited from the bonafide and experienced Khadi Society/ N.G.O/ Trust/ Society who is already involve in color work in industrial means.

JOB DETAILS:-

1. Permanent coloration of the thread and fabric preferably Natural Dye, Reactive Dye and Vat Dye in Khadi, Muslin, Tassar and Silk Fabric at CPC Building, Bakul, Lavpur, Birbhum at per specified rate chart of the Central and or State Government/WBKVIB.
2. Printing works on the fabric like Khadi, Muslin, Tassar and Silk as determined by the Board.

At the time of submission the following documents must be submitted by the intending Khadi Society/ N.G.O/ Trust/ Society who is already involve in color work in industrial means :-

- a) The Bye law of the of the society/NGO.
- b) Pan Card of the Society/NGO
- c) GST Certificate of the Society/NGO.
- d) List of the Governing body duly signed by the Secretary and President.
- e) License for the above mentioned work / Work Experience certificate.
- f) Last year Audited Balance sheet.
- g) Udyam Registration Certificate.
- h) Valid Trade license.
- i) Valid Email ID, Contact No. of the Secretary and President in a letterhead.
- j) Aadhar ID , Pan Card and EPIC of the President, Secretary and Treasurer.
- k) A draft of Rs.10,000/- in the name of the WEST BENGAL KHADI & VILLAGE INDUSTRIES BOARD. (if failed the bid , the amount will be refunded.)

The selected bid holder must follow the followings terms and conditions :-

1. Primarily 3 Years of agreement ,i.e. Memorandum of Agreement (MOA) to be executed.
2. Rent, Electricity, taxes, license fee etc. to be borne by the selecting Bidder.
3. Internal Decoration, Machine installation, Electricity connection to be borne by the bidder.
4. WBKVIB shall have the right of overall supervision of the said premises of the CPC and CFC.
5. An interest free security deposit of Rs.50,000/- (Rupees Fifty Thousand only) after selection and before executing the agreement the said amount to be deposited to WBKVIB.
6. The rent should be paid by the bidder within 4th. of the every month as decided at the time of agreement.
7. The security arrangement should be borne by the bidder.
